### NOTICE OF INTENTION TO ISSUE CITY OF MESQUITE, TEXAS COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION, SERIES 2005

The City of Mesquite does hereby give notice of intention to issue Combination Tax and Revenue Certificates of Obligation, Series 2005, in the maximum principal amount not to exceed \$8,350,000, for paying all or a portion of the City's contractual obligations for the purpose of constructing, improving, equipping and renovating the City's Animal Shelter, Community Service Building, Police/City Hall, and Municipal Center Building and acquiring land for the City Art Center and land in the Central Business District, which has been railroad right-a-way, for Municipal parking, acquisition and installation of equipment and software for the City's record management system and acquisition and installation of emergency sirens; and for paying legal, fiscal, engineering and other professional fees in connection with such projects. The City proposes to provide for the payment of such Certificates of Obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from a limited pledge of surplus revenues of the City's Waterworks and Sewer System, remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve, and other requirements in connection with any of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the Net Revenues of the City's Waterworks and Sewer System. The City Council intends to consider for passage at a Regular Meeting to be held at 3:00 P.M. on April 4, 2005, an Ordinance authorizing the issuance of Combination Tax and Revenue Certificates of Obligation, Series 2005, in the City Council Chambers, at City Hall, 711 N. Galloway, Mesquite, Texas.
