

RESOLUTION NO. 09-2008

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ESTABLISHING PRECINCTS AND THE LOCATION OF POLLING PLACES FOR THE ANNUAL CITY ELECTION; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Mesquite, Texas, has called the annual general election to be held May 10, 2008, for the purpose of electing a Mayor and Councilmembers for Place Nos. 2, 3, 4 and 5; and

WHEREAS, the terms for Mayor and City Council, Place No. 2, are for one-year periods to complete unexpired terms; the terms for City Council, Place Nos. 3, 4 and 5 are full two-year periods; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS;

SECTION 1. That the City election precincts for this election shall consist of the territory located within the corporate limits of the City bearing the following numbers, and the polling places at said election shall be as follows, to wit:


