

RESOLUTION NO. 05-2010

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
MESQUITE, TEXAS, EXPRESSING OFFICIAL INTENT TO
REIMBURSE COSTS OF PROJECTS.

WHEREAS, the City of Mesquite, Texas (the "Issuer"), is a home-rule municipality and political subdivision of the State of Texas; and

WHEREAS, the Issuer expects to pay expenditures in connection with the design, planning, acquisition and construction of the projects described on Exhibit "A," attached hereto, (the "Projects") prior to the issuance of obligations to finance the Projects; and

WHEREAS, the Issuer finds, considers and declares that the reimbursement of the Issuer for the payment of such expenditures will be appropriate and consistent with the lawful objectives of the Issuer and, as such, chooses to declare its intention, in accordance with the provisions of Section 1.150-2 of the Treasury Regulations, to reimburse itself for such payments at such time as it issues obligations to finance the Projects.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Issuer reasonably expects to incur debt, as one or more series of obligations, to reimburse the Issuer for expenditures for the Projects in an amount estimated to be \$21,325,000.


SECTION 2. That all costs to be reimbursed pursuant hereto will be capital expenditures. No tax-exempt obligations will be issued by the Issuer in furtherance of this resolution after a date which is later than 18 months after the later of (1) the date the expenditures are paid; or (2) the date on which the property, with respect to which such expenditures were made, is placed in service.

SECTION 3. That the foregoing notwithstanding, no tax-exempt obligation will be issued pursuant to this resolution more than three years after the date any expenditure which is to be reimbursed is paid.



Acquiring, constructing, installing and equipping additions, improvements and extensions to the City's waterworks and sewer system; constructing and improving streets, roads and alleys including related drainage, signalization, landscaping, lighting and signage; constructing, improving, equipping and renovating a police/city hall facility; constructing and equipping a control tower at the municipal airport; major repairs and renovations to existing municipal buildings, including fire department buildings, Service Center and Arts Center; acquisition of equipment and vehicles for the Fire, Police, Community Development, Public Works, Administration, and Parks and Recreation Departments; and acquisition of computer equipment and software for the Fire, Police, Community Development, Community Services, Administration, Public Works, Library, and Parks and Recreation Departments.




