RESOLUTION NO. 14-2012

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, DIRECTING PUBLICATION NOTICE OF INTENTION TO ISSUE COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION TO **PROVIDE FUNDS** FOR **PUBLIC** IMPROVEMENTS. **FACILITIES** AND EQUIPMENT, INCLUDING STREET IMPROVEMENTS, MUNICIPAL BUILDINGS, VEHICLES, COMPUTER **EQUIPMENT** AND **SOFTWARE** FOR MUNICIPAL **DEPARTMENTS** AND FOR RELATED ISSUANCE COSTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council deems it advisable to give notice of intention to issue combination tax and revenue certificates of obligation of the City of Mesquite, Texas, as hereinafter provided; and

WHEREAS, the City Council finds and determines that such projects are necessary and in the public interest of the City to provide public facilities and equipment for authorized needs and purposes; and

WHEREAS, it is hereby officially found and determined that the meeting at which this Resolution was passed, was open to the public and public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551, Texas Government Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Exhibit "A" attached hereto is a form of Notice of Intention to Issue Combination Tax and Revenue Certificates of Obligation, the form and substance of which is hereby adopted and approved.

SECTION 2. That the City Secretary shall cause said notice to be published in substantially the form attached hereto, in a newspaper, as defined by Subchapter C, Chapter 2051, Texas Government Code, of general circulation in the area of said City, once a week for two consecutive weeks, the date of the first publication thereof to be at least 30 days prior to the date tentatively set for the adoption of the ordinance authorizing the issuance of such certificates of obligation as shown in said notice.

SECTION 3. That this Resolution shall become effective immediately upon its adoption.

CITY OF MESQUITE, TEXAS NOTICE OF INTENTION TO ISSUE COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION

The City of Mesquite, Texas, does hereby give notice of intention to issue combination tax and revenue certificates of obligation, in one or more series, in the maximum principal amount not to exceed \$7,600,000.00, for paying all or a portion of the City's contractual obligations incurred in connection with:

- (i) Constructing and improving streets, roads, alleys and sidewalks including related drainage, signalization, landscaping, lighting and signage;
- (ii) Constructing, improving, equipping and renovating a Police/City Hall facility;
- (iii) Major repairs and renovations to existing municipal buildings, including primarily the Municipal Center and Service Center buildings and lighting at the Service Center;
- (iv) Acquisition of equipment and vehicles for Police, Street, Solid Waste and other municipal departments;
- (v) Acquisition of computer equipment and software for various municipal departments, including upgrade of major software systems; and
- (vi) For paying legal, fiscal, engineering and other professional fees in connection with such projects.

The City proposes to provide for the payment of such combination tax and revenue certificates of obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from a limited pledge of surplus revenues of the City's Waterworks and Sewer System, remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve and other requirements in connection with any of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the Net Revenue of the City's Waterworks and Sewer System. The City Council intends to consider for passage an ordinance authorizing the issuance of such combination tax and revenue certificates of obligation at a meeting to be held at 7:00 p.m. on July 16, 2012, in the City Council Chambers, at City Hall, 757 N. Galloway, Mesquite, Texas.
