WHEREAS, the Colorado Health Facilities Authority (the "Issuer") is a body politic and corporate of the State of Colorado, created under the Colorado Health Facilities Authority Act codified at Article 25 of Title 25 of the Colorado Revised Statutes, as amended; and

WHEREAS, the City of Mesquite (the "City") has been informed by the Issuer that the Issuer has been requested by The Evangelical Lutheran Good Samaritan Society (the "Obligor") to assist it in financing and refinancing, on a tax-exempt basis, the costs of acquisition of home health agency operations in the City, specifically at Heritage Home Healthcare, 700 N. Town East Blvd., Suite 159, Mesquite, Texas 75150 (the "Project"); and

WHEREAS, the Issuer will issue revenue bonds in the maximum aggregate principal amount of \$300,000,000, of which \$12,000,000 will be used for the Project (the "Bonds"); and

WHEREAS, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code") requires that the Bonds be approved by the "applicable elected representative" (the "Representative") after a public hearing following reasonable public notice; and

WHEREAS, with respect to the Bonds, the Representative shall be the City Council of the City; and

WHEREAS, a public hearing was held with respect to the issuance of bonds by the Issuer for the benefit of the Obligor and the Minutes of Public Hearing (the "Minutes") are attached hereto; and

WHEREAS, it is deemed necessary and advisable that this Resolution be adopted.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS THAT:

Section 1. The City Council, as Representative, hereby approves the plan of finance and related issuance of revenue bonds by the Issuer in the maximum aggregate principal amount of \$300,000,000, of which \$12,000,000 will be used by the Obligor for the Project, and further approves the Project as described in the attached Minutes, and such approval shall be solely for the purposes of Section 147(f) of the Code and the City shall have no liabilities for the payment of the Bonds nor shall any of its assets be pledged to payment of the Bonds.
