

RESOLUTION NO. 56-2017

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AMENDING RESOLUTION NOS. 34-2017 AND 35-2017, AS AMENDED BY RESOLUTION NOS. 48-2017 AND 49-2017 BY REVISING THE EXHIBIT "A" ATTACHED TO THE RESOLUTIONS AND REDUCING THE AREAS IN ITS EXTRATERRITORIAL JURISDICTION PROPOSED FOR ANNEXATION BY THE CITY; AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS, with the passage of Resolution Nos. 34-2017 and 35-2017 on September 5, 2017, which were amended by Resolution Nos. 48-2017 and 49-2017, on October 16, 2017, the City Council directed City staff to give written notice of the City's intent to annex certain properties in its extraterritorial jurisdiction ("ETJ") located in Dallas and Kaufman Counties, Texas, as required by V.T.C.A. Local Government Code §43.062 and to prepare a service plan for the areas as required by Local Government Code §43.065; and

WHEREAS, having studied the land use, topography, platting and other physical characteristics of the areas included for annexation in Resolution Nos. 48-2017 and 49-2017, the Director of Planning and Development Services has concluded that reasons exist under generally accepted municipal planning principles and practices for modifying the areas, or portions thereof, to be given further consideration for possible annexation; and

WHEREAS, the City Council has determined that the areas proposed for annexation should be reduced and that Resolution Nos. 48-2017 and 49-2017 and Exhibit "A" attached thereto should be amended to reflect this change.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:


SECTION 1. That Sections 1 of Resolution Nos. 34-2017 and 35-2017, as amended by Resolution Nos. 48-2017 and 49-2017, are hereby amended by revising the Exhibit "A" to those Resolutions with the Exhibit "A" attached to this Resolution, thereby reducing the areas proposed for annexation by the City of Mesquite.


SECTION 2. That except for the areas shown in the revised Exhibit "A" attached to this Resolution, all other areas included in the Exhibit "A" attached to Resolution Nos. 34-2017 and 35-2017, adopted on September 5, 2017, as amended by Resolution Nos. 48-2017 and 49-2017, adopted on October 16, 2017, are hereby eliminated from further consideration and are no longer proposed for annexation into the corporate limits of the City of Mesquite.

SECTION 3. That this resolution shall become effective immediately from and after its passage.
