

RESOLUTION NO. 67-2019

A RESOLUTION EXPRESSING OFFICIAL INTENT TO REIMBURSE, FROM THE PROCEEDS OF OBLIGATIONS TO BE ISSUED BY THE CITY, THE COSTS OF THE RESIDENTIAL STREET RECONSTRUCTION PROGRAM, STREET, ROAD, ALLEY, SIDEWALK AND SCREENING WALL PROJECTS, WATER AND SEWER SYSTEM IMPROVEMENTS, MUNICIPAL BUILDING IMPROVEMENTS AND ACQUISITION OF VEHICLES AND EQUIPMENT AND COMPUTER EQUIPMENT AND SOFTWARE FOR MUNICIPAL DEPARTMENTS

WHEREAS, the City of Mesquite, Texas (the "Issuer"), is a home-rule municipality and political subdivision of the State of Texas; and

WHEREAS, the Issuer expects to pay, or have paid on its behalf, expenditures in connection with the design, planning, acquisition and construction of the projects described on Exhibit "A" hereto (the "Projects") prior to the issuance of tax-exempt obligations, tax credit obligations and/or any other obligations for which a prior expression of intent to finance or refinance is required by federal or state law (collectively and individually, the "Obligations") to finance the Projects; and

WHEREAS, the Issuer finds, considers and declares that the reimbursement for the payment of such expenditures will be appropriate and consistent with the lawful objectives of the Issuer and, as such, chooses to declare its intention to reimburse itself for such payments at such time as it issues Obligations to finance the Projects.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Issuer reasonably expects to incur debt, as one or more series of Obligations, with an aggregate maximum principal amount equal to \$49,700,000 for the purpose of paying the costs of the Projects.

SECTION 2. That all costs to be reimbursed pursuant hereto will be capital expenditures. Unless otherwise advised by bond counsel, all original expenditures will be reimbursed pursuant hereto if such original expenditures were paid prior to the date that is 60 days prior to the date hereof and all original expenditures will be reimbursed pursuant hereto no later than 18 months after the later of (1) the date the original expenditure is paid or (2) the date the project to which such original expenditure relates is placed in service or abandoned, but in no event more than three years after the original expenditure was paid.

SECTION 3. That the foregoing Section 2 notwithstanding, unless otherwise advised by bond counsel, all original expenditures to be reimbursed with qualified tax credit obligations will be reimbursed pursuant hereto only if such original expenditures were not paid prior to the date that is 60 days prior to the date hereof and are reimbursed within 18 months of the date the original expenditure is made.



## Exhibit "A"

Constructing, improving, extending, expanding, upgrading and developing two-lane residential streets, including utility relocation, landscaping, sidewalks, traffic safety and operational improvements, drainage, and the purchase of any necessary right-of-way. Constructing and improving streets, roads, alleys, sidewalks and screening walls including related drainage, signalization, landscaping, lighting and signage; major repairs and renovations to existing municipal buildings; design, land acquisition and construction of Fire Station No. 4; acquisition of equipment and vehicles for municipal departments; and acquisition of computer equipment and software for various municipal departments. Acquiring, constructing, installing and equipping additions, improvements and extensions to the City's waterworks and sewer system.
