RESOLUTION NO. 30-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ADOPTING REVISIONS TO THE CITY OF MESQUITE HOUSING CHOICE VOUCHER ADMINISTRATIVE PLAN; AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the City Council of the City of Mesquite, Texas ("City"), has authorized participation in the Housing Choice Voucher Program of the U. S. Housing Act of 1937, as amended ("Program"); and

WHEREAS, in accordance with 24 C.F.R. § 982.54, the City adopted a written administrative plan ("Plan") establishing local policies for administration of the Program in accordance with U. S. Department of Housing and Urban Development ("HUD") requirements; and

WHEREAS, the Plan must be revised if needed to comply with HUD requirements;; and

WHEREAS, the City Council adopted revisions to the City's Plan in October 2019 and HUD has since revised its Program regulations and requirements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. The HUD Program revisions, more fully described in Exhibit A attached hereto and made part of hereof, are hereby adopted and made a part of the City's Plan.

<u>SECTION 2</u>. The effective date of the Plan, as amended, shall be August 3, 2020.
