

RESOLUTION NO. 37-2020

A RESOLUTION EXPRESSING OFFICIAL INTENT TO REIMBURSE, FROM THE PROCEEDS OF OBLIGATIONS TO BE ISSUED BY THE CITY, THE COSTS OF STREET, ROAD, ALLEY, SIDEWALK AND SCREENING WALL PROJECTS, WATER AND SEWER SYSTEM IMPROVEMENTS, MUNICIPAL BUILDING IMPROVEMENTS AND ACQUISITION OF VEHICLES AND EQUIPMENT AND COMPUTER EQUIPMENT AND SOFTWARE FOR MUNICIPAL DEPARTMENTS.

WHEREAS, the City of Mesquite, Texas (the “**Issuer**”), is a home-rule municipality and political subdivision of the State of Texas; and

WHEREAS, the Issuer will make, or has made not more than 60 days prior to the date hereof, expenditures in connection with the design, planning, acquisition and construction of the projects described on Exhibit A hereto (the “**Projects**”); and

WHEREAS, in certain circumstances, federal and/or state law requires that the Issuer express its official intent to issue obligations to reimburse itself for expenditures paid prior to the issuance of such obligations in order for such expenditures to be eligible for reimbursement from proceeds of such obligations; and

WHEREAS, Section 1.150-2(d)(2) of the Treasury Regulations sets forth limitations regarding the timing of reimbursements made from the proceeds of certain obligations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. The Issuer reasonably expects to reimburse itself for costs that have been or will be paid subsequent to the date that is 60 days prior to the date hereof and that are to be paid in connection with the Projects from the proceeds of obligations to be issued subsequent to the date hereof.

SECTION 2. That the Issuer reasonably expects that the maximum principal amount of obligations issued to reimburse the Issuer for the costs associated with the Projects will be \$30,352,050. Such obligations may be issued in one or more series.


SECTION 3. Unless otherwise advised by bond counsel, any reimbursement allocation will be made not later than 18 months after the later of (1) the date the original expenditure is paid or (2) the date on which the Project to which the expenditure relates is placed in service or abandoned, but in no event more than three years after the original expenditure was paid.

Constructing and improving streets, roads, alleys, sidewalks and screening walls including related drainage, signalization, landscaping, lighting and signage; major repairs and renovations to existing municipal buildings; acquisition of equipment and vehicles for municipal departments; and acquisition of computer equipment and software for various municipal departments. Acquiring, constructing, installing and equipping additions, improvements and extensions to the Issuer's waterworks and sewer system.
