A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ADOPTING THE PUBLIC HOUSING AUTHORITY (“PHA”) 5-YEAR AND ANNUAL PLAN FOR THE HOUSING CHOICE VOUCHER PROGRAM.

WHEREAS, the City Council of the City of Mesquite, Texas, has authorized participation in the Housing Choice Voucher (“HCV”) of the U.S. Housing Act of 1937, as amended; and



- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

**B. 1 -Housing Needs and Strategy for Addressing Housing Needs. (Attachment A)**

The Mesquite Housing Division administers Housing Choice Vouchers (HCV) and Project Based Vouchers. The Housing Division administers 1,446 Tenant Based Housing Choice Vouchers and has 859 on the HCV waiting list.

Of the 1,446 families receiving Housing Choice Vouchers from the Mesquite Housing Division (MHD), 473 are disabled families and 281 of the families on the waiting list are disabled. The need for accessible units for those in the HCV program in Mesquite is larger than the need citywide. As the City of Mesquite continues to grow in population, the need for affordable housing increases for the low and moderate-income households. MHD strategic goals are to collaborate with local organizations to increase opportunities for affordable housing; promote safe and diverse neighborhoods; and seek supportive services for income-deprived families. In order to provide more affordable units, MHD has expanded its jurisdiction 25 miles outside the city’s radius.

The housing needs provided in the City of Mesquite's Consolidated Plan and the MHD’s current waiting list does agree with basic needs in our area. The waiting list is comprised of the following:

### Comments for RAB:

#### Landlord Incentives

- MHD will begin biennial inspections for landlords with a 90% or above pass rate to incentivize landlords for upkeeping their units and leasing to Mesquite Housing tenants.

#### Monthly Open Forum Landlord Meetings

- MHD will introduce monthly open forum meetings for new and prospective landlords.

#### Financial Literacy

- MHD will host meetings for participants to promote financial literacy and self-sufficiency.

### Summary:

Mesquite Housing Division (MHD) will introduce biennial inspections to current landlords as an incentive for consistently meeting Housing Quality Standard requirements per HUD regulations. MHD staff will provide a platform for landlords to connect, ask questions, and become familiar with the program as a mechanism to retain current landlords and recruit new landlords. MHD will host financial literacy meetings to help promote self-sufficiency to program participants.
