

RESOLUTION NO. 60-2023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE SUBMISSION OF THE 2022 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAMS CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER) TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD).

WHEREAS, the U. S. Department of Housing and Urban Development (“**HUD**”) requires entitlement communities to prepare a Consolidated Annual Performance and Evaluation Report (“**CAPER**”) as well as an annual action plan to receive federal housing and community development funding; and

WHEREAS, the City of Mesquite (the “**City**”) is an entitlement city scheduled to receive certain funds under the Housing and Community Development Act annually; and

WHEREAS, the Program Year 2022 CAPER documents progress of how the City allocated grant funds to meet the priorities and needs identified in the Program Year 2022 Action Plan, which covered the period October 1, 2022, to September 30, 2023: and

WHEREAS, the City published a public notice on November 2, 2023, in the *Daily Commercial Record* newspaper and on November 5, 2023, in the *Mesquite News* for a public comment period for the 2022 CAPER from November 17, 2023 – December 1, 2023, and made the CAPER available for public viewing in the lobby of the Community Service’s building and on the Community Service’s webpage: and

WHEREAS, the City conducted public hearings and accepted public comments; and

WHEREAS, the Mesquite City Council has considered the suggestions and recommendations raised through public hearings, public comments, citizen input, and strategic planning.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the 2022 Community Development Block Grant’s Consolidated Annual Performance and Evaluation Report for the City of Mesquite, a copy of which shall be maintained in the City Secretary’s office as an original document, is hereby approved for submission.
