RESOLUTION NO. 40-2024

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE MAYOR TO FINALIZE AND EXECUTE ALL DOCUMENTS NECESSARY TO DESIGNATE THE POSITIONS OF DIRECTOR OF FINANCE, SENIOR FINANCE SYSTEM ANALYST, MANAGER OF BUDGET AND TREASURY, ASSISTANT CITY MANAGER, AND BUDGET ANALYST TO ACT AS THE CITY OF MESQUITE'S AUTHORIZED REPRESENTATIVES FOR TEXAS LOCAL GOVERNMENT INVESTMENT POOL ("TEXPOOL/TEXPOOL PRIME").

WHEREAS, the City of Mesquite, Texas (the "City"), is a local government of the State of Texas and, pursuant to Chapter 2256 of the Texas Government Code, the Public Funds Investment Act ("PFIA"), is empowered to delegate to the public funds investment pool the authority to invest funds and to act as custodian of investments purchased with local investment funds; and

WHEREAS, it is in the best interest of the City to invest local funds in investments that provide for the preservation and safety of principal, liquidity, and yield consistent with the PFIA; and

WHEREAS, the Texas Local Government Investment Pool ("**TexPool/TexPool Prime**"), a public funds investment pool, was created on behalf of entities whose investment objectives in order of priority are preservation and safety of principal, liquidity, and yield consistent with the PFIA; and

WHEREAS, the City invests local funds with and through TexPool/TexPool Prime; and

WHEREAS, on October 2, 2017, the City Council approved Resolution No. 44-2017 that designated authorized representatives to act on the City's behalf in connection with investments made with and through TexPool/TexPool Prime and further authorized participation in TexPool Prime; and

WHEREAS, on September 21, 2020, the City Council approved Resolution No. 41-2020 that reflected the change in personnel for the position of Director of Finance and a title change from Manager of Budget and Financial Analysis to Manager of Budget and Treasury for the City; and

WHEREAS, on October 4, 2021, the City Council approved Resolution No. 67-2021 that reflected the change in personnel for the position of Manager of Accounting for the City; and

WHEREAS, on July 3, 2023, the City Council approved Resolution No. 29-2023 that reflected the change in personnel for the position of the Manager of Budget and Treasury for the City; and

WHEREAS, due to a change in personnel for the City positions of Director of Finance and Manager of Budget and Treasury, and the departure of the Manager of Accounting Services on

September 20, 2024, plus a need to include the Senior Finance System Analyst and the Budget Analyst as authorized representatives for the City and replacing the City Manager with the Assistant City Manager as the City's representative designated to perform only inquiries of selected information, TexPool/TexPool Prime requested the City provide a Resolution Amending Authorized Representatives designating and identifying the persons and positions authorized to act on the City's behalf, and that said Resolution be in the form attached hereto as Exhibit 1 and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

<u>SECTION 1</u>. That the Resolution Amending Authorized Representatives, attached hereto as <u>Exhibit 1</u>, is hereby approved and the Mayor authorized to finalize and execute said Resolution.

SECTION 2. That the positions and persons identified in the Resolution Amending Authorized Representatives are authorized representatives of the City and are each hereby authorized to undertake the actions authorized for them in the attached Resolution.

SECTION 3. That this Resolution amends and supersedes Resolution No. 29-2023 only so far as this Resolution conflicts with Resolution No. 29-2023, which otherwise remains valid and operative.

<u>SECTION 4.</u> That this Resolution and the attached Resolution Amending Authorized Representatives shall continue in full force and effect until amended or revoked by the City and until the Texas Local Government Investment Pool receives a copy of such amendment or revocation.
